Nor-Cal Hot Shots – Player/Parent Contract

This contract is designed to ensure a positive and encouraging environment for all players and parents. Our goal as an organization is to create an environment where the players will not only learn and grow as athletes, but will also be taught good sportsmanship and the value of being part of a team.

Parents should at all times behave in a positive manner during practices and games. Parents should not be involved in conversations or behavior that could be detrimental to the individual players, coaches and/or the team. Remember, this is travel ball, and playing time is not guaranteed. Therefore, parents must agree to and abide by the following:

- Do not enter dugouts (during game and/or practices). Please stay away from the dugout area.
- Refrain from making negative comments regarding players, coaches, officials, opponents, and/or other fans.
- Refrain from the use of inappropriate or offensive language.
- Please do not approach coaches during tournaments (either before or after games) regarding playing time or coaching strategies. Please contact the manager and a meeting will be scheduled to discuss any subject.
- Do not participate in any unsportsmanlike conduct.
- Do not put down or criticize your child, or any other players either verbally or via multimedia.
- Do not coach any players during games and practices unless asked to do so by a member of the coaching staff.
- DO encourage and praise your child for their effort, for competing fairly and for exhibiting a positive attitude.
- DO encourage your child as they work on and develop their skills.
- DO encourage your child to practice and play their best at all times, regardless of the outcome.
- DO demand that your child play the game with respect towards all involved in the game.

It is equally important that the Nor-Cal Hot Shot players conduct themselves in a manner that will be professional and will reflect in a positive manner on the organization. Therefore, the following code of conduct will be required of all players:

- Players shall at all times exhibit an attitude of respect for their coaches, teammates, officials, parents, and opponents.
- Players shall support and encourage their teammates.
- Players shall refrain from any unsportsmanlike conduct.
- Players shall not use inappropriate or offensive language
- Players shall not post any inappropriate or negative material about teammates or coaches via any multimedia method.
- Players must maintain a 2.5 or above GPA in school.
- Players should notify coaches of any and all scheduling conflicts that may prevent participation in practices and/or games. Players are required to attend all scheduled practices and playing time at tournaments may be adjusted for players who do not show up to practices.

Finally, NO refunds will be made if the player quits the team she is playing on. If a player cannot play due to injury, their fees will be transferred to the next season on a “case by case” basis. If a player has to be removed from a team for any reason, the parent must request a refund in writing (grievance process) to the Board of Directors within seven (7) days from the day she was released. The Board will then review the parents' request and will respond back to them within thirty (30) days. This grievance process does not guarantee a refund. The Hot Shots organization will not tolerate any sort of online bullying by players or parents against other players or parents and if this sort of behavior is being conducted, the Nor-Cal Hot Shots reserve the right to immediately dismiss players / parents from the organization if such action is warranted by the Nor-Cal Hot Shots Board of Directors.
